

## PROPOSED RESOLUTION

The Management Committee hereby proposes;

- (1) To open a new class of Term Membership.
- (2) To separate the monthly subscription of golfing family subscription into two categories;
  - (a) Spouse
  - (b) Children under the age of 18 years old

Rationale: Another avenue to increase the income of the club through the acceptance of Term Membership.

- (3) Disposal of fixed assets as listed below:

Unit	Description of asset
18	Old Blue Sofa unit Zanussi Dishwasher
42	Old Red Banquet Chairs
12	Old Rattan Chairs

Rationale: The fixed assets are beyond cost economical repair.

In view of the above proposals (1) and (2), there is a need to amend the club constitution.

The Management Committee hereby proposes;

**To add additional clauses to the current Club Constitution;**

### **1. FOR THE INCLUSION OF TERM MEMBERSHIP;**

#### **Clause 6: MEMBERSHIP**

There shall be ELEVEN (11) Categories of membership as follows:-

- (11) Term Membership (Please refer to Section 16)

#### **Clause 16. TERM MEMBER**

- (1) Term Membership shall be open to all individuals at a yearly fee to be determined by the Committee and it is inclusive of monthly subscription fee. Such application shall be considered by the Committee who may approve or reject without giving any reason.
- (2) The Term shall be for a period of 1 year.
- (3) A Term Member shall be entitled to enjoy all the club's facilities, except for credit signing facilities, the right to vote. He shall have no voice in the affairs of the management or the Club and shall not be entitled to introduce a guest to the Club.
- (4) A Term Member shall enter competitions expressly declared by the Committee to be open to Term Members.

### **2. FOR THE MONTHLY SUBSCRIPTION OF GOLFING FAMILY MEMBER TO BE SEPARATED INTO TWO CATEGORIES;**

#### **Existing Club Constitution Clause 10(2)**

- (2) All Golfing family members shall pay a monthly subscription fee of RM30.00 per person, or any amount as determined by the Management Committee from time to time. Wives/Husbands and Children under 18 years of age who are not Junior Members of Life, and Full Members, and are by virtue of the above. Non-golfing family members are exempted from payment of any subscription

**Propose Club Constitution Clause 10(2) to read as;**

Golfing family members shall be divided into two categories:

(a) Wives / Husbands of Life and Full Members

(b) Children under 18 years of age.(Who are not Junior Members of Life and Full Members).

Wives/Husbands of Life and Full Members shall pay a monthly subscription fee of RM60.00 per person, or any amount as determined by the Management Committee from time to time.

Children under 18 years of age (Who are not Junior Members of Life and Full members) shall pay a monthly subscription fee of RM30.00 per person, or any amounts as determined by the Management Committee from time to time.

Non-golfing family members are exempted from payment of any subscription
