Captain Report 2017

In my report last year, I mentioned that a substantial amount of money would be withdrawn from the fixed deposit for the construction of the buggy house and the purchase of 22 units buggies. The reserved sum for the buggies were spent. The construction of the buggy house is in progress with 70% of its work completed.

I would like to emphasize here that any business entity would know that a huge amount of money kept in the bank would not profit its business. Though the Club is an exclusive member's club, it is of no exception too. Our sole dependence on member's monthly subscription to survive year after year is becoming increasingly burdensome in battling with the rapid rise in inflation and cost.

Spending a sum of RM1.5million on the buggy project is deemed as an investment because it will definitely generate funds to the club. We will continue with this trend for now and subsequent years to come. Sand buggy tracks would be constructed in rough areas to enable a steady income at all times. At the moment, buggies can only be used during fine weather. While this project is in progress, the committee endeavors to source for other opportunities to enhance the financial strength of the club.

Over the past few years of my captainship, I can say that we have done well in the overall aspect of managing this club. We saved cost by repair and maintaining the very old machines. In the midst of doing that, we slowly build up our reserves through cost savings. We started by investing in a few buggies at a time and with the buggy's self-generated funds, we added to its numbers. To date, we owned 52 new buggies which yielded about half a million ringgit into the club's funds in year 2017. The total income generated from buggy since 2012 till now stood at RM1.42million. The availability of buggies have attracted many golfers to come from other regions for golf. It boosted the green fee income incidentally. While we invested in buggies, we also invested in new turf equipment which we could not afford before. The outcome of the new machines coupled with the existing ones and a team of dedicated course and green workers has elevated the standard and quality of our golf course. Positive feedbacks about our golf course continued to spread.

With more golfers patronizing the golf course, we now concentrate on making it more beautiful and improving our club's image as a whole would be our primary objective. As time goes by with unpredictable events happened around the globe which impacted the club indirectly, we need to face and adapt to these changes constructively. And so for the Club to change for the better, our mind set must change too. My committee has been working closely with me these few years. We got ourselves involved in the day to day affairs of the Club. Here, I sought support from members in the tenacity of speaking positively about your own club and most importantly to the golfing members that you would be regulation abiding members who would repair the divots, ball marks, rake the bunkers and drive the buggies avoiding soggy areas, the fringe of the greens and play within your own pace of play.

In moving forward, the committee is committed to maintain a reasonable standard for the clubhouse and the golf course facilities. It is either we remain status quo or we upgrade our facilities. This depends very much on the financial health of the Club. You may have already noticed minor renovation such as a new buggy parking space was being created using the clubhouse expenditure budget last year. Beside this, there are a list of 'wish list' that the committee looked forward to change but due to financial constraint, priority is set on the immediate 'to do' list.

In terms of activities, we are in a healthy and lively state. Our calendar is always packed with golf competitions. When there is no event scheduled during the weekends, members would self-create

their own to draw in the crowd. This helped as a whole from the club's revenue to that of the F&B and the pro shop's business.

The existence of the ladies and junior sections with their many programs and social gatherings lined up kept the club busy. Through them, programs such as the weekly junior coaches and 9holes game were introduced to their non-golfing friends. These sections are avenues that open the path to bring in new members to the Club.

I present herewith my report as Captain of the Club on the affairs of the Club for 2017. Please bear with me for any short comings which I as well as my committee might have not managed to perform up to your expectation.

CLUB ADMINISTRATION

- 1. The Hon. Secretary, Mr. Agan Maran took care of all staff administration and overseeing the day to day affairs of the Club. I see this as a no end job. There are bound to be tough cases here and there but then all is under controlled. Rectification was carried out spontaneously so as to ensure no recurrence of the same mistakes again.
- 2. The Management Committee had twelve Management Meetings for the year 2017 and other numerous sub-committee meetings and even discussions after their game of golf in the evening.
- 3. The staff too had their meetings as well to discuss on ways to improve their working condition. This is an on-going process. The recruitment of new staff began when we approached the 3Q of the year. We did not managed to retain all the newly recruited staff for two reasons, most of them resigned due to personal problems and disciplinary issues.
- 4. The Club sent its staff to two exposure trips on 2nd to 3rd March, 2017 at Kelab Golf Sarawak, 8th May, 2017 at Sutera Harbour Golf Club and 11th to 15th October, 2017 at KLGCC for NHS Seminar and Gogolf Roadshow, Turf Management Seminar and Field Day and Educational Program for Turf Equipment respectively.
- 5. Following the roadshow held in KGS, the club participated in the Go-Golf program by putting up 4 slots on Tuesday and Wednesday for Go-golf members to register for golf online.
- 6. Worker's party was held on 30th September, 2017.
- 7. For the year 2017, we have approved 30 new members, 1 Term Member and 29 members resigned by way of their memberships being transferred. The total number of members as at 31st December, 2017 is 905.
- 8. New Members' Night was organized on 6th September, 2017 to welcome the new members. There were two other occasions whereby New Member's night were organised and it was cancelled due to poor response.
- 9. A Disciplinary Committee was appointed and it comprised of the chairman Tuan Haji Han and 3 other members of the sub-committee, Mr. Tony Ham, Mr. Reginald Kevin Akeu, Mr Wagner Lisa and Mr. Andrew Victor Nub.
- 10. There were amendments to the club's bylaws. The Order of Play ByLaw B6 1 and 1A were amended:

- 10a. (1) Daily tee-off from '0700 Hrs to 0830 Hrs/1130 Hrs to 1329 Hrs at Front Nine / 1130 Hrs to 1329 Hrs at Back Nine:'
 - (1) A) Only full members, golfing family members and junior golfing members below the age of 18 years old or member from reciprocal clubs with official Handicaps are allowed to book and play at 7 minutes intervals.
- 10b. Order ByLaw B6 1 (C) was deleted:
 - C) Those who are teeing off at the Front Nine will have priority over the Back Nine before 1530 p.m. on weekdays only. On Prime Time Booking days both Front Nine and Back Nine have priority at all time while still in the same group and on condition that they must complete each nine within 2 hours 20 minutes. Two balls match playing the Front and Back Nine will not have priority'.

FINANCIAL

- Prudent spending is what the committee has been practicing all this while. The budget
 which is prepared and approved would not be spent unless it is absolutely necessary or
 sometimes a certain expenditure items would be overspent due to unforeseen
 circumstances.
- 2. We have a separate report written by the Hon. Treasurer, Mr. Michael Tang. We have a surplus of RM206K in 2017. There was an increase in surplus of funds as compared with year 2016.
- 3. This is the first time that the club proposed a budget of RM50K for club contingency. The committee deemed this is necessary. By the term 'contingency' itself, this is a lump sum provision which may or may not be enough should there be an unforeseen case.
- 3. One of the MC's greatest challenges where finances is concerned is dealing with members who default in paying their outstanding dues. With the slow economy, it is anticipated that the collection of outstanding dues will be increasingly difficult. The Hon. Treasurer continued to do his best in recovering every single debt within his means. Expelling members from the club and writing off as bad debts would be the committee's last resort when all means of communication with the defaulting member have failed.
- 4. The FPX payment gateway is no longer available. Instead, the Club subscribed to JomPAY and this facility is made available to members effective December 2017. It is our hope that with this convenience, members would pay their dues promptly.

CLUBHOUSE

The following works were carried out in 2017:

- 1. A temporary buggy shed was erected on the committee's carpark to house an additional 22 new buggies. This was done as there was an unexpected delay by MCC in approving the construction of the new buggy house.
- 2. The pathway from the carpark beside the putting green to the mini gate was reconstructed and widened to accommodate the buggies driving on it. The empty space beside it was cemented for buggy parking.

- 3. Two units of shoes and golf sets washing area were constructed beside the clubhouse opposite the 18th Green and beside the security guard's house.
- 4. A new set of PA System was purchased and installed at the 1st Floor Function Hall.
- 5. A new function stage at the golfer's terrace was constructed. This improved the image of the club. From now on, we would have a proper stage for mini and medium size prize presentations.
- 6. One new unit 2.5HP air-conditioner was purchased to replace the broken down unit in the Men's Restroom.
- 7. One new unit TV was purchased and installed at the Golfer's Terrace for tournament's scores display and ASTRO viewing.
- 8. Caterer This would be the last year for the catering contract at the Clubhouse, thereafter its expiry, the said contract would be tender for new bidders. The operator at Front Nine canteen submitted an early termination of the contract while the Back Nine's contract remained in force. We have a new operator at the Front Nine Canteen this year.

COURSE MAINTENANCE

- 1. I would say we have achieved our 3 stars golf course standard. This is the best that we can do with the resources which we have. Maintaining the golf course at this current standard would be our priority now. Next, we would look at beautification of the course by planting more trees and flowers on the golf course.
- During the year, the Club bought one unit of green mower. There is a need to invest in one additional unit in case the old units break down. This mower gives the greens fine quality cut. Beside this unit being bought, we also bought a fertilizer spreader and a set of brush reels. These are equipment necessary to give the greens and fairways a classy look and feel good for play.
- 3. The retaining wall of pond 6 and pond 7which had collapsed were reconstructed using Selangan Batu hardwood.
- 4. Members are urged to extend their cooperation to repair ball marks and divots to keep the golf course in good condition. Currently, the course & greens maintenance team has to engage an extra worker to carry out this job.
- 5. The task to remove foreign grass on the fairways has been incorporated into the gardeners' scope of work. Less foreign grass is seen on the fairway nowadays.
- 6. Sawdust was applied on the flower beds on the tee-boxes and different parts of the golf course for beauty and easier maintenance.

- 7. New plants and flowers were planted to replace some other flowers on the island of Hole 10 and 11 and behind Hole 3 to give this area a new look and beautiful scenery.
- 8. We have on a few occasions allowed the use of buggies during soggy ground condition. While we understood that this would spoil the ground, the committee's had other concerns such as shortage of caddies, golfers with health condition who were unable to walk as well as it is a loss to the club. Here, I would like to remind golfers NOT to drive the buggies up to the fringe of the greens and always avoid driving through soggy grounds areas.
- 9. It was for two years that monkeys posed threats to golfers on the golf course. Many efforts were taken to solve this problem including engaging the Forestry Department but to no avail. The problem was solved later when one course worker successfully caught two of the adult monkeys, one at a time on two different occasions and it was handed over to the Forest Department. One huge hornet hive was removed by our course worker also.
- 10. RM50,000 would be budgeted to build sandy buggy tracks to allow the use of buggies at all times. This amount is not enough to cover the whole golf course. It would be done stage by stage starting with the very critical area. It is hoped that golf with the use of buggy would be possible during all seasons. The Committee has not considered a proper buggy track like other golf courses firstly because of funds constraint and secondly, it would involve a higher maintenance cost on the buggies and turf equipment.
- 11. The problem of river erosion at Hole 14 has not been solved. We will continue to follow up with the Sarawak Government seeking assistance from them to construct the retaining wall.
- 12. During the year, one long patch of Serangoon grass measuring 10 sq. feet at Tee Box 3 was stolen during the night. The committee has decided to engage an additional security guard and a buggy would be used to patrol the golf course at night.
- 13. The stinky smell coming from the pond at Hole 13 during dry season still remain unsolved due to the level of the river bank is higher than the bed of the pond. It has been a very nasty issue for more than a decade. Members with the expertise are most welcomed to propose a long term viable solution.
- 14. Trees were not trimmed this year. This process will resume in the coming year.
- 15. The sand on the bunker is one of the most talk about issues among golfers. The proper bunker sand would cost the Club a lot of money and furthermore, it is not available in Miri. The committee has decided to put this on hold as most of club's funds is being committed to the construction of the buggy house and a new pro shop.

COMPETITIONS

Competitions held in 2017 were:-

- 1. Our very own KGM Open which is also SGA Sanctioned held in Miri:-
 - The 29th KGM Amateur Open Golf Championship (YBhg Dtk Patinggi Tan Sri Dr George Chan Hong Nam and YBhg Dtn Patinggi Puan Sri Datuk Lorna Enan Muloon Chan Trophies held from

22nd to 24th September, 2017. Mr. Lee Ka Tung from SGC with a gross score of 207 and Ms. Mirabel Ting from KGM with a gross score of 220 emerged as the champions in the men and ladies category respectively. Hole-in-one prizes of cash prize of RM280,000 sponsored by the patron, YBhg Datuk Patinggi Tan Sri Dr. George Chan Hong Nam and myself was out for grabs but unfortunately, no one got it. Caddy shortage problem was not an issue where buggies were the first time being used for KGM Open.

- The Organising Chairman and Referee for this event was myself. The Tournament Director for this event was Mr. Faisal.
- 2. Throughout the year, the golfing calendar was packed with club, sponsored and inter-club competitions. One new competition was added to the golf calendar; the KGM Inter-Community Golf. This is a non-budgeted event. Fund for the competition was self-generated.
 - The Strokeplay club championship was held on 5th, 11th and 12th March, 2017. The trophy was won by Mr. Lee Kah Ching with a gross score of 232.
 - The Matchplay club championship was held on 2nd, 8th and 9th April, 2017. The trophy was won by Mr. Kunjin Sandhu.
 - Champion of Champions was held on 2nd and 3rd December, 2017. The trophy was won by Mr. Daniel Sagoh.
- 3. The Captain's Trophy was held on 25th February, 2017. Peoria System was used to compute the handicap of the participants for this event. The trophy was won by Mr. Yong Soon Sin with a nett score of 68.
- 4. Inter-club golf game with Miri-KRPM was held on 15th April, 2017 at KGM KGM Team won with a total nett score of 727, and Miri-Panaga was held on 26th August, 2017 at KGM KGM Team won with a total nett score of 747.
- 5. Ballsweep Competitions were held on 18th February, 22nd April, 20th May, 28th October, 18th November and 16th December, 2017. This is a self-funding event.
- 6. KGM Inter-community Golf Tournament was held on 12th August, 2017. The Chinese Team emerged as the Champion Team.
- 7. Various other sponsored competitions were held in 2017 of which some were held annually many years here in KGM. Our sincere thanks go to all our sponsors for their continuous support towards the Club.

- 9. Another Bonus Reward is on offer to the top point achiever for points accumulated from Monthly Medal Golf Competitions, Ballsweep, festival golf competitions and other competitions as and when it is announced from June 2017 to 3Rd. March 2018. Ms. Muren Wan, Mr. Daniel Sagoh and Mr. Chong Yiet Yieng won this fully paid golfing trip. They shall be invited to play at 4 rounds of golf in Hangzhou in October 2018.
- 10. Private Charity Golf held at KGM in 2017 were;
 - Wisma St. Joseph Charity Golf on 5th August, 2017.
 - BEM ARC's Fundraising Golf on 10th June, 2017.
- 11. Apart from organised competitions, there were plenty of self-arranged golf competitions initiated among members:
 - Kobelco Golf Challenge on 18th March, 2017.
 - DGA President's Cup on 8th July, 2017.
 - Kejohanan Golf Amal Antara Penjara on 29th July, 2017.
 - Inaugural Malaysia Orang Ulu Golf on 30th April, 2017
 - Remang Closed Golf on 19th August, 2017.
 - Retirees Golf Meet on 25th November, 2017.
- 12. We have since two years ago started a selection point system taken from the Monthly Medal Competitions. Members who qualified under the point system were selected to represent the club in tournaments held at other golf clubs with part of its expenses subsidized by the Club. Sarawak Inter-Club held at Bintulu Golf Club from 7th to 8th October, 2017. 12 members participated and were given an allowance of RM700 per member
- 13. There were issues of golfers posting wrong scores on their score cards during competition. The committee wished to remind golfers to check their scores and handicaps before depositing their score cards into the score card deposit box.

HANDICAP

A very sensitive task and I believe Esaw has given his best, though there were still plenty of comments every now and then. There are still some minorities believed to have manipulate their scores for submission. Members are strongly advised to stand up to report to committee for those who intentionally inflate their scores for score submissions. We need your corporation to curb such manipulation in order that prizes are not fallen into the hands of foul play golfers.

CADDIES

1. Caddies competition cum BBQ party was organised and sponsorships received in small and large were generously contributed by members led by Mr. Kong Sieng Tung on 11th December, 2017 with the aim to keep them together and maintain a rapport between the committee, members and the caddies. The number of caddies have dwindled over the years as there is less opportunity for them to earn an income through caddying. On normal days, many golfers used buggies. This has led them to leave the Club for greener pastures.

2. We still have quite a small number of regular caddies who would replace divots every week and in return they are given the opportunity to play 18holes golf every Monday.

RULES

- 2 Rules Classes were conducted with comprehensive teaching by the Rules Chairman, Dr. John Yeo on 1st July and 25th November, 2017. This is a compulsory class for all new beginners. Golfers who would like to refresh their knowledge are encouraged to attend as well.
- 2. With effect from 1st January, 2018, the local rules to Rule 6-6d of the Rules of Golf would be modified. If a competitor returns a score for any hole lower than actually taken due to failure to include one or more penalty strokes, that before returning the score card, he did not know he had incurred, he will not be disqualified. In such circumstances, the competitor incurs the penalty prescribed by the applicable Rule, but there is no additional penalty for a breach of Rule 6-6D.

This Exception does not apply when the applicable penalty is disqualification from the competition.

PENALTY FOR BREACH OF LOCAL RULE

Match Play – Loss of Hole

Stroke - Two Strokes

The above Local Rule shall be used in all MGA/SGA sanction events starting January 2018.

SWIMMING POOL

- 1. The swimming pool has always been the least patronized facility. Yet the club can't do without it as it is an added facility to members. Most of the time, it is utilized by spouses and children.
- 2. The swimming pool is currently experiencing major breakdown. After 26 years of operation there is a major problem with the filtration, electrical switch board and cabling systems. As this involved a lot of money to undergo a major repair, the committee has decided to close the swimming pool to allow that major repair to be carried out and engaging a good and effective contractor to put the system back in place on condition that the budget allocated for this major is approved at the AGM.
