

7TH DATO SEBASTIAN TING TROPHY JUNIOR GOLF CHAMPIONSHIP 2011

Conditions of competition

1. DATE

7th Sebastian Ting Trophy Championship 2011 will be held from 7th June to 8th June 2011.

2. VENUE

3. ELIGIBILITY

The Championship is opened to junior amateur golfers who have not reached the maximum age allowed in their age group on the last day of the competition with a valid NHS/USGA Handicap index or a local handicap.

4. FORMAT

The Championship shall be decided by stroke play over two (2) rounds of 18 holes ,

Subjected to the Committee's right in the event of circumstances which make the playing of 36 holes impracticable to cancel any round at its discretion.

Championship Event

- It shall be decided by stroke play over 36 holes.
- The winner shall be the competitor who returns the lowest aggregate GROSS score at the end of the Championship.

Gross Event

- It shall be decided by stroke play over 36 holes.
- The winner shall be the competitor who returns the lowest aggregate gross score at the end of the Championship in each age group.

5. CLASS

6. ENTRY

All entries will be subjected to the approval of the Junior Tournament Committee, who reserves the right to accept or decline entry without giving any reason for its decision.

The field shall be limited to 100 players subjected to first come first serve basis.

CLOSING DATE.

Monday , 23rd May, 2011

7. DECISION OF TIES

In the event of a tie for the first place in the Championship, the boys and girls tying shall proceed to hole by hole play-off until the winner is decided by elimination.

The Tournament Committee shall decide the sequences of holes for the play-off.

In the event of a tie for any other position, the tie shall be decided by a count-back system of matching the scorecards in the following order.

- A. Last 18 holes
- B. 2nd last 18 holes
- C. Last 9 holes
- D. Last 6 holes
- E. Last 3 holes
- F. And finally the last hole

8. PRIZES

Prizes shall be awarded to the winner, runner-up, and third for all classes.

9. TIME OF STARTING

- A. The Tournament Committee will make the the draws and the starting times for the first round and will be posted at the club house or official hotel. Such posting will be considered sufficient notice for information and distribution. The draw for subsequent round will be arranged according to scores, the lowest score will tee-off last from the tee. The committees reserves the right to vary the starting times, at its absolute discretion, before tee-off time.
- B. The players shall start at the time laid down by the Tournament Committee .In the absence of circumstances which warrant waiving the penalty of disqualification as provided in Rule 33-7,if a player arrives at his starting ready to play within five minutes after his starting ,the penalty for failure to start on time shall be two strokes at the starting hole instead of disqualification. Penalty for lateness beyond five minutes is DISQUAIFICATION.

10. RULES OF PLAY

The rules of golf as approved by R & A Rules Limited and their interpretation as contained in the 'Decisions on the Rules of golf' these conditions of competition and the Local Rules established by the Tournament Committee for the competition will apply.

11. MANAGEMENT

The 7th Sebastian Ting Trophy Golf Championship shall be managed by the junior Tournament Committee of Kelab golf Miri whose decisions in all matters relating to the championship is final.

12. TRANSPORTATION

Players must not ride on any form of transportation during a stipulated round unless authorized by the Committee.

Boys and Girls Class A and B must carry their own bags or use a trolley.

Boys and Girls Class C and D are permitted to engage a caddy to carry their bags. These caddies must be arranged through the Club.

PENALTY FOR BREACH OF CONDITION

Two strokes for each hole at which any breach occurred. Maximum penalty per round: Four strokes. Use of any unauthorized form of transportation must be discontinued immediately upon discovery that a breach has occurred. Otherwise, the player is disqualified.

13. TEEING GROUND

Boys Class A and B play from Blue Tee.

Boys Class C play from Red Tee.

Boys Class D play from Pink Tee.

Girls Class A and B play from Red Tee.

Girls Class C play from Pink Tee.

14. SUSPENSION OF PLAY DUE TO DANGEROUS SITUATION (NOTE TO RULE 6-8b)

The specimen condition in the Rule of Golf is in effect-see Appendix Part C-5

NOTE: Suspension of play for a dangerous situation will be signaled by a prolonged note of horn.

All other suspension s will be signaled by three consecutive short notes of a horn, repeated. In either case , resumption of play will be signaled by two short note of a horn, repeated.

15. PACE OF PLAY

Each hole has been given a maximum completion time based upon the length and difficulty of the hole .

The maximum time allotted for the completion of 18 holes will be available prior to play.

16. RETURN OF SCORE CARD

A player's score card is deemed officially returned to the Committee when he has casted his score card into a card collection box located at the score recording area.

17. RESULT OF CHAMPIONSHIP

When the championship is presented to the winner, the results of the competition are deemed officially announced and the competition is closed.

18. ETIQUETTE, BEHAVIOUR ON THE COURSE

The following are considered "SERIOUS BREACH OF ETIQUETTE" for this competition:-

- I. Usage of hand phone during a round to the annoyance and distraction of other players.
- ii. Verbal abuse of fellow competition r/official/staff.
- iii. Intentionally distracting or offending fellow competitors.
- iv. Any other 'breaches of etiquette' not listed above but are deemed to be serious by the Committee.

19. INDEMNITY / LIABILITIES

In signing the Entry Form, participants in this championship shall indemnify and not hold liable, SGA, the sponsors, the organizers or the Host Club for any loss or damages to their equipments or personal belongings or harm or any form of injuries that the participants of the Championship may suffer as a result of the participant in this Championship.

20. DISPUTES AND DOUBTFUL POINTS

Any dispute and doubtful point on the rules shall be referred to the Tournament Committee as soon as possible on the completion of the round.

21. DECISIONS

If The Committee has appointed a Referee ,his decision is final(rule 34-2).In the absence of a Referee , any dispute or doubtful point on the Rules shall be referred to the Tournament Committee, whose decision shall be final.(Rule 34-3)
